Shared Services provides high-quality, cost-effective finance, human resources, and information technology services to nonprofit organizations. These services are designed to increase operational efficiency, reduce administrative burden, and enhance organizational stability. By outsourcing these critical functions to Ascend, nonprofits gain access to specialized expertise and scalable solutions that would otherwise be cost-prohibitive. In FY25, Ascend managed \$97.4 million in revenue, supported 1,320 employees and 818 network users. As a result, supported organizations saved as estimated \$5 million in costs for these services.
